## External Equivalency Timeline Quick Reference

A matrix of NWCG S Course to A Course Equivalencies has been listed in the IAT Guide since January 1999. This document includes a timeline of the year each equivalency was granted as well as a listing of other external equivalencies currently offered within IAT.

Timelines listed in this document identify what A courses are granted as an equivalency based on the date of the certificate or the completion date from an IQCS training record. You can use this document to determine what equivalencies you will receive.

Go to the S Course title in the tables below and locate the year column that matches the date on the certificate or IQCS training record. The A Courses listed in that column will be what the you will receive as a course equivalency. Example: If an S-270 certificate is dated November 2004, the student receives credit for S-270 and equivalencies for A-101, A-103, A-104, A-105 & A-106. If the certificate is dated April 2014 the student receives credit for S-270 and an equivalency for A-104.

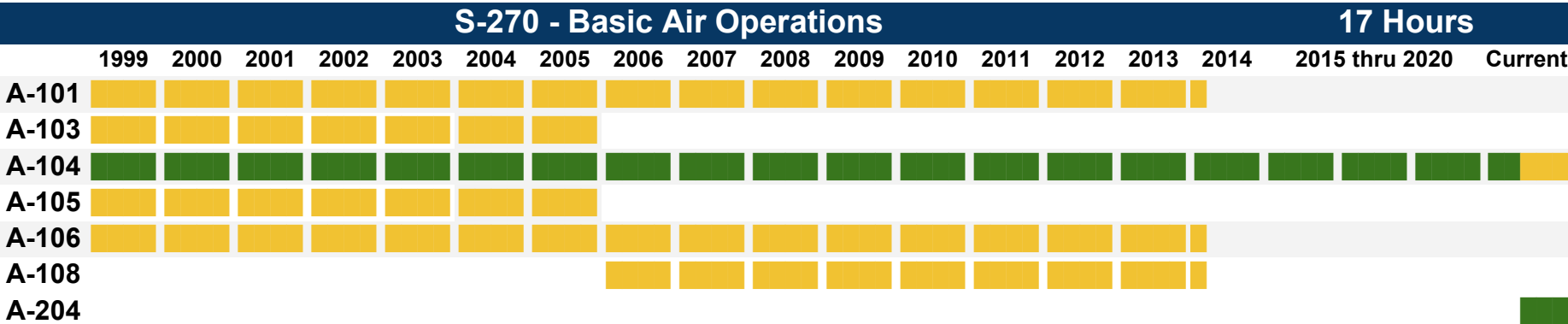
Between May 2003 and January 2006, the S Course to A Course Equivalency Matrix was not listed in the IAT Guide. The IAT Sub-Committee identified a need to cover this gap by using the matrix listed in the May 2003 guide.

**Important Note:** Over the years, many NWCG courses have been recorded within the IAT system giving credit to students. Those courses automatically post equivalencies to the student transcript. **Please DO NOT upload old certificates for classes already recorded in your IAT transcript.**

<b>Equivalency Offered in Past IAT Guides</b>	These equivalencies were offered in past IAT Guides and are no longer active, students will receive credit for these courses if the certificate or IQCS record uploaded reflects a date that falls within the range listed for these equivalencies.
<b>Equivalency Offered in Current IAT Guide</b>	These equivalencies are offered in the current IAT Guide, students will receive credit for these courses if the certificate or IQCS record uploaded reflects a date that falls within the range listed for these equivalencies.

A-219 is frequently taught outside of IAT but not entered into the IAT system by an IAT instructor, this equivalency will allow those who received a certificate outside of IAT to have it entered into their IAT training record. *(Verification/Approval by UATA)*

**NOTE: RT-219 is not a recognized course** by the Interagency Aviation Training system or the Federal Wildland Fire Qualifications Supplement. This has been discussed with the Interagency Aviation Training Subcommittee and the triennial requirement for the HELR position is a complete A-219 not a partial course. We need confirmation that this training was a complete A-219 (including field exercises), we can accept the certificate with a letter from the instructor stating it was a full A-219.

Students can now receive an equivalency to A-310 Overview of Crew Resource Management for N9059 & RT9059F classes they took outside of IAT as well as when they are scheduled within IAT. *(Verification/Approval by UATA)*
